### Nominee's Personal Statement -

As an executive member of the British Hypertension Society, I will bring a proactive, solutionsdriven mindset to advance our mission of reducing the burden of hypertension in the UK and Ireland. My vision aligns with the BIHS goals of fostering innovation and promoting a national standard for best practice in hypertension care. My experience in clinical medicine, education and research make me a strong candidate for this role.

I have been an active member of the BIHS since 2022 and in this short time, attended annual meetings, joined the educational programmes standing committee and more recently contributed to the working group on hypertension centre accreditation.

I have led the Hypertension clinic in my trust since my appointment as a Consultant Nephrologist in Sunderland and South Tyneside NHS Foundation Trust in 2022. I have developed a standardised model for the investigation and management of patients with hypertension that has improved patient outcomes locally and through this work, gained a deep appreciation for the challenges of managing hypertension in our population and its wider impact on public health.

My collaborative approach has led me to build partnerships with our local ICB and GP networks to design referral protocols, treatment algorithms and reduce health inequalities in our region, an important endeavour that I feel that BIHS should continue to champion. I believe I can draw on this experience as an executive member of the society and support BIHS members in developing their own service and promote a culture of shared learning.

In clinical research, I am Principle Investigator for the PURL study in our region and we are currently recruiting patients referred to the Hypertension clinic with support from our research team. I look forward to bringing further research studies in our field to the North East and as an executive member, I would support initiatives to expand research opportunities to centres with less experience in clinical research and use my recent experience to support their development.

I am also committed to education and raising awareness about hypertension and its prevention. I hold a lead educational role within my trust and I have regularly been described as an effective and compassionate educator. As part of the Educational Programmes Standing Committee, I am committed to adopting new teaching methods, including online platforms and social media, to make our educational content more accessible to clinicians and patients which I believe will elevate the BIHS as a world-leading voice in Hypertension strategy.

I am enthusiastic about contributing more to the society and feel that my personal attributes and experience lend themselves to a more integral role within the executive committee.
